## CERTIFIED ALCOHOL AND OTHER DRUG ABUSE COUNSELOR STUDENT FINANCIAL AGREEMENT SPRING 2019

I, the undersigned student, by signing the McDermott Center Student Payment agreement and by registering for The McDermott Learning Center (CADC) classes, promise to pay to Haymarket Center all tuition as described below.

**Please choose one of the following payment options and initial your selection:**

**OPTION 1 – Payment in Full \$1,800**

Arrangement under which full amount is due by **April 2, 2019** - Amount includes \$200 discount

\_\_\_\_\_ Pay \$500 (Five hundred dollars) at the time of registration and the remaining amount of \$1,300 (Thirteen hundred dollars) by **April 2, 2019**.

**OPTION 2 - Payment Plan \$ 2,000**

Arrangement under which we will accept payment of your outstanding balance in installments

\_\_\_\_\_ Pay \$500 (Five hundred dollars) at the time of registration. We will then accept payment of the account in six consecutive, monthly installments of \$ 250.00 (Two hundred fifty), commencing **April 2, 2019** and continuing on the 1<sup>st</sup> day of each successive month until paid in full. **Late fee of \$25.00 a month will be accessed to any overdue accounts.**

Payments may be made by credit card (Visa, Master-card, Discover, American Express), cash, money order or check. A \$35.00 fee will be charged for all reversed credit card payments and returned checks. Subsequent checks will not be accepted. Students who do not fulfill their obligations on or about **September 1, 2019** will not receive their certificate of completion and will not be permitted to continue with their Internship Program.

I understand that monthly payments for tuition owed to Haymarket Center must be current in order to attend classes and receive certification. I understand that my enrollment may be terminated due to non-payment of monthly charges. Students who are accepted must deposit \$500 upon acceptance. Withdrawals on or before **March 19, 2019** will be refunded at 100% less \$25 administrative fee. Withdrawals on or before **April 2, 2019** will be refunded at 100% less \$150 administrative fee, then forfeit tuition.
