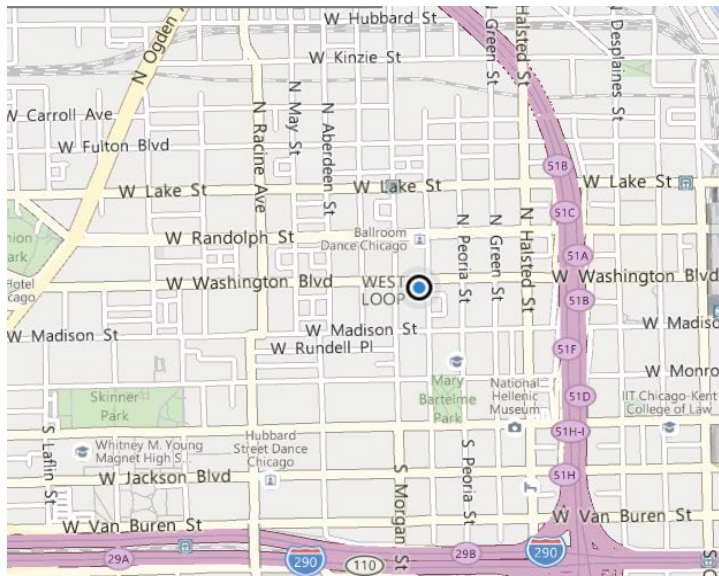

## **PROGRAM DESCRIPTION**

The Work Release Alternative Program (WRAP) is an alternative sentencing option for adult (18+) offenders of Driving Under the Influence of Alcohol and/or Drugs (DUI/DUID). The program requires residential confinement but allows for approved work release time.

### **PROGRAM COMPONENTS AND SERVICES:**

- Forty (40) hours per week of work release time.
- Thirty (30) days of residential confinement plus monitoring.
- Seventy-five (75) hours of Intensive Outpatient substance abuse treatment.
- Family Component.
- Health and Wellness Education.
- Involvement in self-help support groups (AA, NA).
- Assessment for Domestic Violence and Gambling.
- Community Service performed in-house at Haymarket Center (Total of 40-60 hours per week).
- Breathalyzer and urine drug testing.

Certified treatment professionals, trained in criminogenic behaviors, design treatment plans to address the individual needs of the participants plus facilitate all individual and didactic/therapeutic group sessions.

## **PROGRAM REQUIREMENTS:**

- Completion of all program components.
- Total abstinence from all mind/mood altering substances.
- Adherence to all Haymarket Center's policies and procedures.
- Compliance with all court requirements.

### **REPORTING:**

Reporting is provided to the Circuit Court of Cook County through the Social Service Department, Central States Institute, and/or Probation.

### **CONTINUED CARE/AFTERCARE:**

All offenders who are ordered to Haymarket's WRAP are expected minimally to complete a six month Continued Care/Aftercare counseling program. This is to be done at Haymarket Center unless the sentencing judge permits it to be completed elsewhere.

### **FEES:**

Fees are assessed upon intake and vary according length of stay and individual treatment needs. For more information about fees, or for questions related to cost coverage, please contact our Coordinator of Managed Care at (312) 226.7984 Ext. (484).
